IMPORTANT VISA INFORMATION

For all types of visa an applicant has to submit his/her original passport (Valid for at least six months) along with it photocopy, two recent passport size photographs (white background) and other supporting documents, which can be helpful in obtaining visa.

Following type of visas can be applied for:-

a) **TOURIST VISA:-**

When the Visa Officer is satisfied about the purpose of visit. **Single/Double Entry Visa (Fee £53 / £76 respectively)** is issued to a tourist holding a British Passport.

b) **FAMILY VISA:-**

A Single, Double or Multiple Entry Visa is issued to family visitors holding British Passports. For British passport holders with expired Pakistani passport (issue date not earlier than 01 Jan 1975), concession is granted. Normal visa fee for **Single Entry £53, Double Entry £76 and Multiple Entry £240**. (Dual National Adults for **Single Entry £27, Double Entry £38 and Multiple Entry £120** and Children under 18 years **Single Entry £13, Double Entry £19 and Multiple Entry £60**).

Such applicants must produce their expired Pakistani passport and photocopy. Applicants with parents holding Pakistani passports get the same concession provided, they produce original detailed birth certificate and their parent's Pakistani passport and photocopy. Passports of denounced nationality will not be accepted.

c) **PILGRIM VISA:-**

Pilgrim visa for Single Entry is issued to those who wish to visit Holy Places (Shrines/Gurdawaras) in Pakistan. A notice of two months is required for such applications. The fee is **£53**.

d) **BUSINESS VISA:-**

For business visas, applicant has to submit Company letter (UK based) and an invitation letter from Pakistan with other supporting documents, which can be helpful in obtaining visa. Business visa has three categories. **Single Entry for £80, Double Entry for £114 and Multiple Entry (one year) for £240**.

e) **WORK AND STUDENT VISA:-**

This type of visa requires two to three months to process. Job offer letter / University / College acceptance letter and other supporting documents will be required.

f) **DIPLOMATIC AND OFFICIAL VISA:-**

Diplomatic & Official (in some cases) visas are issued free of charge to those who are going on an official assignment. A note verbal from the FCO would be required.

g) **VISAS FOR NON-UK CITIZENS:-**

Applicants of Passports other than holding British passports should provide proof of residential status in the UK. Their passport must contain appropriate entry. Alternatively a utility bill (Electricity, Gas or Water) or Bank statement in applicants name may suffice.

h) **VISA FOR MEDIA:-**

Requests for visa for Media Professional are routed through Information / Press division of Pakistan High Commission.

i) **TRANSIT VISA:-**

Transit visas are issued to those who are travelling to other countries through Pakistan. Applicants of transit visas should produce the original ticket of their country of final destination. Transit stay is valid for 72 hours.

j) **BANK CHARGES:-**

There is a charge of £2.00 per visa application.

The High Commission of Pakistan reserves the right to change the rules or reject visa application without assigning any reason.

FEE

- Visa fee is subject to periodical revision without notice.
- Visa fee is charged per person and not per passport. If children are endorsed in the passport additional fee will be charged.
- Fee is only payable in cash or postal order made out in the name of High Commission for Pakistan. Personal cheques are not accepted.
- Visa fee is not refundable even if visa is refused.
- All fee mentioned above are **exclusive** of a £2.00 additional bank surcharge per application for visa/passport being charged at all Pakistan consulates including London.
